Subject: Dividend payment

The Management Board of Ronson Europe N.V. with its registered seat in Rotterdam (the "Company"), hereby informs that during its session of 10 August 2016 the General Meeting of Shareholders adopted resolution regarding payment of dividend for the financial year 2015 and regarding dividend and dividend payment date.

Pursuant to the Resolution no. 1 the General Meeting of Shareholders of Ronson Europe N.V. acknowledged the proposal of the Board of Managing Directors included in the Current Report No. 16/2016 and decided to allocate a part of the retained earnings reserve of the Company in the amount of PLN 21,788,800 for paying out a dividend for financial year 2015 and to declare a dividend in cash of PLN 0.08 per ordinary share. All of the Company's shares, i.e. 272.360.000 are covered by the dividend. The dividend day was determined as 17 August 2016 and the dividend payment date as 24 August 2016. Dividend will be payable through the National Depository of Securities S.A. (Krajowy Depozyt Papierów Wartościowych S.A.) with its registered seat in Warsaw.
