- on 19 March 2019 purchased 6 093 Issuer's treasury shares for an average price of PLN 0.859 per share. The total value of shares purchased amounted to PLN 5 233.67. The purchased shares constitute 0.00371% of the share capital of the Issuer and votes at the General Meeting of the Issuer,
- on 20 March 2019 purchased 6 808 Issuer's treasury shares for an average price of PLN 0.84 per share. The total value of shares purchased amounted to PLN 5 718.72. The purchased shares constitute 0.00415% of the share capital of the Issuer and votes at the General Meeting of the Issuer,
- on 21 March 2019 purchased 7 153 Issuer's treasury shares for an average price of PLN 0.844 per share. The total value of shares purchased amounted to PLN 6 034.40. The purchased shares constitute 0.00436% of the share capital of the Issuer and votes at the General Meeting of the Issuer,
- on 22 March 2019 purchased 7 605 Issuer's treasury shares for an average price of PLN 0.823 per share. The total value of shares purchased amounted to PLN 6 259.16. The purchased shares constitute 0.00464% of the share capital of the Issuer and votes at the General Meeting of the Issuer,

The total number of own shares held by the Issuer after considering the above transactions is 38 117 shares, which constitute 0.02324% of the share capital of the Issuer and votes at the General Meeting of the Issuer.
