- on 7 May 2019 purchased 2,220 Issuer's treasury shares for an average price of PLN 0.873 per share. The total value of shares purchased amounted to PLN 1,937.50. The purchased shares constitute 0.00135% of the share capital of the Issuer and votes at the General Meeting of the Issuer,
- on 8 May 2019 purchased 6,775 Issuer's treasury shares for an average price of PLN 0.871 per share. The total value of shares purchased amounted to PLN 5,900.25. The purchased shares constitute 0.00413% of the share capital of the Issuer and votes at the General Meeting of the Issuer,
- on 9 May 2019 purchased 6,708 Issuer's treasury shares for an average price of PLN 0.881 per share. The total value of shares purchased amounted to PLN 5,906.58.
  The purchased shares constitute 0.00409% of the share capital of the Issuer and votes at the General Meeting of the Issuer,
- on 10 May 2019 purchased 6,259 Issuer's treasury shares for an average price of PLN 0.884 per share. The total value of shares purchased amounted to PLN 5,535.68. The purchased shares constitute 0.00382% of the share capital of the Issuer and votes at the General Meeting of the Issuer,

The total number of own shares held by the Issuer after considering the above transactions is 278,453 shares, which constitute 0.16978% of the share capital of the Issuer and votes at the General Meeting of the Issuer.
