## **Subject: Purchase of own shares**

- on 27 May 2019 purchased 2,188 Issuer's treasury shares for an average price of PLN 0.852 per share. The total value of shares purchased amounted to PLN 1,863.68. The purchased shares constitute 0.00133% of the share capital of the Issuer and votes at the General Meeting of the Issuer,
- on 28 May 2019 purchased 2,222 Issuer's treasury shares for an average price of PLN 0.849 per share. The total value of shares purchased amounted to PLN 1,886.59. The purchased shares constitute 0.00135% of the share capital of the Issuer and votes at the General Meeting of the Issuer,
- on 29 May 2019 purchased 1,626 Issuer's treasury shares for an average price of PLN 0.845 per share. The total value of shares purchased amounted to PLN 1,373.84. The purchased shares constitute 0.00099% of the share capital of the Issuer and votes at the General Meeting of the Issuer,
- on 30 May 2019 purchased 2,511 Issuer's treasury shares for an average price of PLN 0.86 per share. The total value of shares purchased amounted to PLN 2,159.46. The purchased shares constitute 0.00153% of the share capital of the Issuer and votes at the General Meeting of the Issuer,
- on 31 May 2019 purchased 2,482 Issuer's treasury shares for an average price of PLN 0.865 per share. The total value of shares purchased amounted to PLN 2,146.94. The purchased shares constitute 0.00151% of the share capital of the Issuer and votes at the General Meeting of the Issuer,

The total number of own shares held by the Issuer after considering the above transactions is 326,994 shares, which constitute 0.19937% of the share capital of the Issuer and votes at the General Meeting of the Issuer.
