- on 2 September 2019 purchased 1,575 Issuer's treasury shares for an average price of PLN 0.861 per share. The total value of shares purchased amounted to PLN 1,355.75. The purchased shares constitute 0.00096% of the share capital of the Issuer and votes at the General Meeting of the Issuer,
- on 3 September 2019 purchased 1,781 Issuer's treasury shares for an average price of PLN 0.850 per share. The total value of shares purchased amounted to PLN 1,513.85. The purchased shares constitute 0.00109% of the share capital of the Issuer and votes at the General Meeting of the Issuer,
- on 4 September 2019 purchased 1,664 Issuer's treasury shares for an average price of PLN 0.850 per share. The total value of shares purchased amounted to PLN 1,414.40. The purchased shares constitute 0.00101% of the share capital of the Issuer and votes at the General Meeting of the Issuer,
- on 5 September 2019 purchased 1,520 Issuer's treasury shares for an average price of PLN 0.840 per share. The total value of shares purchased amounted to PLN 1,276.80. The purchased shares constitute 0.00093% of the share capital of the Issuer and votes at the General Meeting of the Issuer,
- on 6 September 2019 purchased 1,705 Issuer's treasury shares for an average price of PLN 0.846 per share. The total value of shares purchased amounted to PLN 1,441.75. The purchased shares constitute 0.00104% of the share capital of the Issuer and votes at the General Meeting of the Issuer.

The total number of own shares held by the Issuer after considering the above transactions is 455,706 shares, which constitute 0.27785% of the share capital of the Issuer and votes at the General Meeting of the Issuer.
