**Subject: Purchase of own shares**

The Management Board of Ronson Development SE (the “**Issuer**”) hereby announces that within the implementation of the share buyback program approved by the Resolution No. 3 of the Extraordinary General Meeting of the Issuer dated 24 January 2019 (current report No. 2/2019 dated 24 January 2019), the brokerage house, acting on the Issuer’s account:

- on 4 November 2019 purchased 2,135 Issuer’s treasury shares for an average price of PLN 0.821 per share. The total value of shares purchased amounted to PLN 1,753.20. The purchased shares constitute 0.00130% of the share capital of the Issuer and votes at the General Meeting of the Issuer,
- on 5 November 2019 purchased 2,124 Issuer’s treasury shares for an average price of PLN 0.820 per share. The total value of shares purchased amounted to PLN 1,741.68. The purchased shares constitute 0.00130% of the share capital of the Issuer and votes at the General Meeting of the Issuer,
- on 6 November 2019 purchased 2,244 Issuer’s treasury shares for an average price of PLN 0.817 per share. The total value of shares purchased amounted to PLN 1,832.64. The purchased shares constitute 0.00137% of the share capital of the Issuer and votes at the General Meeting of the Issuer,
- on 7 November 2019 purchased 2,353 Issuer’s treasury shares for an average price of PLN 0.835 per share. The total value of shares purchased amounted to PLN 1,965.33. The purchased shares constitute 0.00143% of the share capital of the Issuer and votes at the General Meeting of the Issuer,
- on 8 November 2019 purchased 2,705 Issuer’s treasury shares for an average price of PLN 0.835 per share. The total value of shares purchased amounted to PLN 2,258.68. The purchased shares constitute 0.00165% of the share capital of the Issuer and votes at the General Meeting of the Issuer.

The total number of own shares held by the Issuer after considering the above transactions is 553,491 shares, which constitute 0.33747% of the share capital of the Issuer and votes at the General Meeting of the Issuer.

Attached the Issuer submits a list with detailed information on transactions of purchase of own shares effected between 4– 8 November 2019.
