- on 3 December 2019 purchased 3,309 Issuer's treasury shares for an average price of PLN 0.829 per share. The total value of shares purchased amounted to PLN 2,743.38.
  The purchased shares constitute 0.00202% of the share capital of the Issuer and votes at the General Meeting of the Issuer,
- on 4 December 2019 purchased 5,200 Issuer's treasury shares for an average price of PLN 0.825 per share. The total value of shares purchased amounted to PLN 4,290.00.
  The purchased shares constitute 0.00317% of the share capital of the Issuer and votes at the General Meeting of the Issuer,
- on 5 December 2019 purchased 5,110 Issuer's treasury shares for an average price of PLN 0.825 per share. The total value of shares purchased amounted to PLN 4,215.75. The purchased shares constitute 0.00312% of the share capital of the Issuer and votes at the General Meeting of the Issuer,
- on 6 December 2019 purchased 5,025 Issuer's treasury shares for an average price of PLN 0.825 per share. The total value of shares purchased amounted to PLN 4,145.63. The purchased shares constitute 0.00306% of the share capital of the Issuer and votes at the General Meeting of the Issuer.

The total number of own shares held by the Issuer after considering the above transactions is 632,803 shares, which constitute 0.38583% of the share capital of the Issuer and votes at the General Meeting of the Issuer.
