Subject: Purchase of own shares

The Management Board of Ronson Development SE (the “**Issuer**”) hereby announces that within the implementation of the share buyback program approved by the Resolution No. 3 of the Extraordinary General Meeting of the Issuer dated 24 January 2019 (current report No. 2/2019 dated 24 January 2019), the brokerage house, acting on the Issuer’s account:

- on 23 December 2019 purchased 2,819 Issuer’s treasury shares for an average price of PLN 0.795 per share. The total value of shares purchased amounted to PLN 2,241.11. The purchased shares constitute 0.00172% of the share capital of the Issuer and votes at the General Meeting of the Issuer,
- on 27 December 2019 purchased 3,013 Issuer’s treasury shares for an average price of PLN 0.805 per share. The total value of shares purchased amounted to PLN 2,425.48. The purchased shares constitute 0.00184% of the share capital of the Issuer and votes at the General Meeting of the Issuer.

The total number of own shares held by the Issuer after considering the above transactions is 671,924 shares, which constitute 0.40968% of the share capital of the Issuer and votes at the General Meeting of the Issuer.

Attached the Issuer submits a list with detailed information on transactions of purchase of own shares effected between 23 – 27 December 2019.
