## **Subject: Purchase of own shares**

The Management Board of Ronson Development SE (the "Issuer") hereby announces that:

- 1. acting on the basis and within the limits of the authorization resulting from the Resolution No. 21 of the Extraordinary General Meeting of the Issuer dated 30 June 2020 (current report No. 19/2020 dated 30 June 2020), and the resolution of the Management Board of 8 July 2020, specifying the detailed terms of acquisition Issuer's own shares, which were approved by the Supervisory Board (current report No.22/2020 dated 8 July 2020), the Management Board of the Issuer submitted to the Brokerage House of PKO BP an order to purchase shares of the Issuer on the terms specified in the abovementioned resolution of the Management Board;
- 2. within the implementation of the share buyback program mentioned above, Brokerage House of PKO BP, acting on the account of the Issuer:
  - on 8 July 2020 purchased 12,034 Issuer's treasury shares for an average price of PLN 1.079 per share. The total value of shares purchased amounted to PLN 12,981.38. The purchased shares constitute 0.00734% of the share capital of the Issuer and votes at the General Meeting of the Issuer,
  - on 9 July 2020 purchased 12,675 Issuer's treasury shares for an average price of PLN 1.120 per share. The total value of shares purchased amounted to PLN 14,190.76. The purchased shares constitute 0.00773% of the share capital of the Issuer and votes at the General Meeting of the Issuer,
  - on 10 July 2020 purchased 13,172 Issuer's treasury shares for an average price of PLN 1.105 per share. The total value of shares purchased amounted to PLN 14,557.48. The purchased shares constitute 0.00803% of the share capital of the Issuer and votes at the General Meeting of the Issuer.

The total number of own shares held by the Issuer after considering the above transactions is 772,403 shares, which constitute 0.47095% of the share capital of the Issuer and votes at the General Meeting of the Issuer.

Attached the Issuer submits a list with detailed information on transactions of purchase of own shares effected between 8 - 10 July 2020.

The Issuer plans to inform about transactions made as part of the share buyback program collectively, once a week.

In addition, the Issuer informs that as a result of a typing mistake in the report No. 22/2019 "Preliminary information about number of units sold and delivered by the Ronson group companies in the second quarter of the year 2020" of July 8, 2020 the report number was incorrectly provided. The correct report number is 23/2020. The content of the current report has remained unchanged.
