- on 20 July 2020 purchased 7,016 Issuer's treasury shares for an average price of PLN 1.244 per share. The total value of shares purchased amounted to PLN 8,725.66. The purchased shares constitute 0.00428% of the share capital of the Issuer and votes at the General Meeting of the Issuer,
- on 21 July 2020 purchased 13,407 Issuer's treasury shares for an average price of PLN 1.373 per share. The total value of shares purchased amounted to PLN 18,405.03. The purchased shares constitute 0.00817% of the share capital of the Issuer and votes at the General Meeting of the Issuer,
- on 22 July 2020 purchased 18,769 Issuer's treasury shares for an average price of PLN 1.329 per share. The total value of shares purchased amounted to PLN 24,949.70. The purchased shares constitute 0.01144% of the share capital of the Issuer and votes at the General Meeting of the Issuer,
- on 23 July 2020 purchased 550 Issuer's treasury shares for an average price of PLN 1.295 per share. The total value of shares purchased amounted to PLN 712.25.
 The purchased shares constitute 0.00034% of the share capital of the Issuer and votes at the General Meeting of the Issuer,
- on 24 July 2020 purchased 12,063 Issuer's treasury shares for an average price of PLN 1.292 per share. The total value of shares purchased amounted to PLN 15,580.38. The purchased shares constitute 0.00736% of the share capital of the Issuer and votes at the General Meeting of the Issuer.

The total number of own shares held by the Issuer after considering the above transactions is 860,758 shares, which constitute 0.52482% of the share capital of the Issuer and votes at the General Meeting of the Issuer.
