- on 10 September 2020 purchased 8,639 Issuer's treasury shares for an average price of PLN 1.198 per share. The total value of shares purchased amounted to PLN 10,346.80. The purchased shares constitute 0.00527% of the share capital of the Issuer and votes at the General Meeting of the Issuer,
- on 11 September 2020 purchased 8,071 Issuer's treasury shares for an average price of PLN 1.2 per share. The total value of shares purchased amounted to PLN 9,685.20. The purchased shares constitute 0.00492% of the share capital of the Issuer and votes at the General Meeting of the Issuer.

The total number of own shares held by the Issuer after considering the above transactions is 994,776 shares, which constitute 0.60653% of the share capital of the Issuer and votes at the General Meeting of the Issuer.
