Subject: Purchase of own shares

The Management Board of Ronson Development SE (the “**Issuer**”) hereby announces that within the implementation of the share buyback program approved by the Resolution No. 21 of the Ordinary General Meeting of the Issuer dated 30 June 2020 (current report No. 19/2020 dated 30 June 2020), the brokerage house, acting on the Issuer’s account:

- on 21 October 2020 purchased 9,904 Issuer’s treasury shares for an average price of PLN 1.452 per share. The total value of shares purchased amounted to PLN 14,380.80. The purchased shares constitute 0.00604% of the share capital of the Issuer and votes at the General Meeting of the Issuer,
- on 22 October 2020 purchased 9,810 Issuer’s treasury shares for an average price of PLN 1.459 per share. The total value of shares purchased amounted to PLN 14,313.87. The purchased shares constitute 0.00598% of the share capital of the Issuer and votes at the General Meeting of the Issuer.
- on 23 October 2020 purchased 9,825 Issuer’s treasury shares for an average price of PLN 1.469 per share. The total value of shares purchased amounted to PLN 14,431.88. The purchased shares constitute 0.00599% of the share capital of the Issuer and votes at the General Meeting of the Issuer,

The total number of own shares held by the Issuer after considering the above transactions is 1,160,634 shares, which constitute 0.70766% of the share capital of the Issuer and votes at the General Meeting of the Issuer.

Attached the Issuer submits a list with detailed information on transactions of purchase of own shares effected between 19 – 23 October 2020.
