- on 18 November 2020 purchased 12,635 Issuer's treasury shares for an average price of PLN 1.316 per share. The total value of shares purchased amounted to PLN 16,622.06. The purchased shares constitute 0.00770% of the share capital of the Issuer and votes at the General Meeting of the Issuer,
- on 19 November 2020 purchased 11,965 Issuer's treasury shares for an average price of PLN 1.310 per share. The total value of shares purchased amounted to PLN 15,673.45. The purchased shares constitute 0.00730% of the share capital of the Issuer and votes at the General Meeting of the Issuer.
- on 20 November 2020 purchased 9,042 Issuer's treasury shares for an average price of PLN 1.295 per share. The total value of shares purchased amounted to PLN 11,712.32. The purchased shares constitute 0.00551% of the share capital of the Issuer and votes at the General Meeting of the Issuer,

The total number of own shares held by the Issuer after considering the above transactions is 1,293,865 shares, which constitute 0.78889% of the share capital of the Issuer and votes at the General Meeting of the Issuer.
