Subject: Purchase of own shares

The Management Board of Ronson Development SE (the “**Issuer**”) hereby announces that within the implementation of the share buyback program approved by the Resolution No. 21 of the Ordinary General Meeting of the Issuer dated 30 June 2020 (current report No. 19/2020 dated 30 June 2020), the brokerage house, acting on the Issuer’s account:

- on 4 January 2021 purchased 5,475 Issuer’s treasury shares for an average price of PLN 1.340 per share. The total value of shares purchased amounted to PLN 7,336.56. The purchased shares constitute 0.00334% of the share capital of the Issuer and votes at the General Meeting of the Issuer,
- on 5 January 2021 purchased 8,065 Issuer’s treasury shares for an average price of PLN 1.375 per share. The total value of shares purchased amounted to PLN 11,090.35. The purchased shares constitute 0.00492% of the share capital of the Issuer and votes at the General Meeting of the Issuer,
- on 7 January 2021 purchased 8,406 Issuer’s treasury shares for an average price of PLN 1.417 per share. The total value of shares purchased amounted to PLN 11,908.40. The purchased shares constitute 0.00513% of the share capital of the Issuer and votes at the General Meeting of the Issuer,
- on 8 January 2021 purchased 9,378 Issuer’s treasury shares for an average price of PLN 1.475 per share. The total value of shares purchased amounted to PLN 13,832.55. The purchased shares constitute 0.00572% of the share capital of the Issuer and votes at the General Meeting of the Issuer.

The total number of own shares held by the Issuer after considering the above transactions is 1,520,559 shares, which constitute 0.92711% of the share capital of the Issuer and votes at the General Meeting of the Issuer.

Attached the Issuer submits a list with detailed information on transactions of purchase of own shares effected between 4 – 8 January 2021.
