Subject: Conclusion of a significant agreement for purchase of real estate by a subsidiary of the Issuer

The Management Board of Ronson Development SE (the "Issuer") hereby announces that the Issuer's subsidiary, "Ronson Development spółka z ograniczoną odpowiedzialnością – Naturalis" spółka komandytowa (the "Company") on 14 October 2021 concluded an agreement, on the basis of which it acquired undeveloped real estate located in Szczecin with a total area of approx. $34,777 \text{ m}^2$ (the "Property") (the "Agreement").

The sale price was set at PLN 21,000,000.00 (twenty one million zlotys) net increased by the VAT due.

According to Issuers initial evaluation it shall be feasible to construct on the Property a development project with the total PUM area not less than 23,000 sqm.

The terms and conditions of the Agreement concluded by the Company do not differ from standard contractual provisions of agreements of that type.

Information on the conclusion of the Agreement constitutes confidential information due to the significance of the Agreement in the context of the potential implementation of a development project on the Property.
